**Dear FE and HE providers,**



To many it will be no surprise that according to the World Health Organisation ["one in three women globally, around 736 million, have been subjected to physical or sexual violence in their lifetimes."](#) There have been many recent conversations on the topic of violence against women and as important as they are it's also important to take care of your own welfare and mental health, more on this in Your Welfare below along with support available.

It has been a busy March, you may have seen me present at the DBS or the ETF conferences or you may have attended one of the larger training sessions on offer. Due to the popularity of the open sessions there are more organised for April, details are below so do come along. ### Further Education

Ofsted have released news around inspections, saying "Ofsted will inspect schools and further education & skills (FES) providers in the summer term to provide reassurance about how well children and learners are catching up, but it will not resume a full programme of graded inspections until September." ## Online World Updates

In an effort to keep you up to date on movement within the online world I'll be continuing this section whenever there is news on the subject.

### **4Chan / 8Kun**

March 15th saw the anniversary of the Christchurch terrorist attack in which 51 people lost their lives. There has been some evidence of the celebration of the attack on 4Chan and 8Kun, and GNET have produced a comprehensive report on the activity of the imageboards around the anniversary of the attack and the types of content being produced. ## **Gab**

Some may have seen the BBC article ["Teen who called himself Hitler sentenced for terror offences"](#) which details the case of a 16 year old recently sentenced for terror offences. The article references Gab specifically:

*"On the Gab social media site he glorified the murder of the MP Jo Cox by a neo-Nazi, as well as the far-right killer responsible for the deadly Finsbury Park attack in June 2017."*

Those who have attended the Online Platforms and Extremist Content session will be familiar with Gab as a platform, and everyone will be familiar with the unacceptability of the glorification of terrorist acts. Accessing and using Gab isn't an immediate cause for concern, but online safety should be encouraged alongside critical thinking skills particularly in the context of the online world.

## **Independent Review of Prevent**

The Terms of Reference for the Independent Review of Prevent have been released and are available to read in full [here](#), with an overview below:

*"The Review will consider the strategy as it relates to all forms of terrorism and will consider the following in particular:*

- *is Prevent achieving its objectives to support those vulnerable to being drawn into any form of terrorism? These objectives, as set out in CONTEST 2018, are to:*
  - *tackle the causes of radicalisation and respond to the ideological challenge of terrorism*
  - *safeguard and support those most at risk of radicalisation through early intervention, identifying them and offering support*
  - *enable those who have already engaged in terrorism to disengage and rehabilitate*
- *how effectively and efficiently is Prevent being delivered at both the local and national levels and how well lessons are learned?*
- *how effectively does Prevent interact with other safeguarding and vulnerability strategies, and what are the critical dependencies and common threads?*
- *how effective is the Statutory Prevent Duty, and how effectively is it being implemented?*
- *how to respond to criticisms and complaints?*
- *what should the government consider in the development of its approach to engage with and support people vulnerable to being drawn into terrorism over the next 5 years as the threat evolves?"*

The "[Ways of Working](#)" document has also been released, it provides an overview of the activity the Review will include, and the way in which it will be carried out, including more detail on how the Review will go about answering each of the questions set out in the objectives of the Review's [Terms of Reference](#).

## Hope Not Hate's State of Hate: 2021

Hope not Hate release an extensive report on an annual basis around current trends in extremism. I linked a new report in the last digest - the State of Hate 2020 European Edition - but the traditional UK based report for 2021 has now been released and is available at the below link:

## iREPORTit App

As mentioned in the previous digest the iREPORTit app is now live. As a reminder the iREPORTit app will allow people to refer worrying or disturbing content to the CTIRU easily, effectively and, crucially, completely anonymously.

There should be no safe space for terrorists online – the CTIRU (Counter Terrorism Internet Referral Unit) have a team of specially trained officers who can assess each referral and take appropriate action including referring to other related teams if needed.

I have promotional materials which I'm more than happy to send round so do let me know if you'd like these sent to you. Personally, I've downloaded the app and it is exceedingly easy to use, has a simple layout, and gives a nice easy way to report disturbing and terrorist content. I've also reported content using the app and it took a mere 20 seconds!

## Your Welfare

As mentioned in the introduction, the murder of Sarah Everard may have affected you and people you know in many ways. It has brought many conversations to the forefront but that may be difficult for some people to discuss. Considering the WHO research shows one in three women globally have been subjected to physical or sexual violence in their lifetimes there is a large chance that many people we all know may have been subjected to such violence.

I know I have had conversations around violence against women with friends and family who have found it difficult to express to partners, husbands, and family the constant risk assessment many women undertake on a daily basis. They're important conversations to have, but they can also be distressing.
